Solar Energy Veteran, Educator, and Humanitarian to Lead SunEnergy Power International

Bend, Oregon, February 14, 2008 / -- The Board of Directors of SunEnergy Power International (SEPI) announced the appointment of Walt Ratterman as Chief Executive Officer of this 501(c)(3) nonprofit organization. Mr. Ratterman is also a Director and officer of SEPI's sister company SunEnergy Power Corporation (SEPC). Mr. Parsons added, "During SEPC's startup, SEPI has developed and implemented renewable energy projects in partnership with other nonprofit organizations, assisting them with the necessary field experience, and expects these valuable relationships to continue as we grow."

Mr. Ratterman has been serving as the Chief Project Officer for both SEPC and SEPI and has been instrumental in implementing numerous PV projects in Asia, Africa, and South America. Walt was recently featured in an award-winning PBS documentary titled "Beyond the Call" and was recognized for his extraordinary efforts and philanthropy in aiding those in dire need in very dangerous parts of the developing world. According to Mr. Ratterman, training is the key to make these projects last. The hallmark of every SEPI project, therefore, is that a major emphasis is placed on teaching the local population how to design, build, and maintain the systems.

"I am absolutely delighted to lead SEPI. We've reached the point in SunEnergy's growth that it now makes sense to split out the responsibilities so that each organization can focus on its own unique mission. I'm looking forward to the next level of growth for both SEPI and SEPC.
